---- Voting Instructions for WAC 2024 Bylaws Change Proposal to Membership ----

A 2024 Election Issues document has been prepared that contains detailed information about each ballot measure. There are four ballot measures on which members may vote. Each ballot measure is presented as an 'approve' or 'dissaprove' choice.

Please vote your preference for each measure on the ballot page, and return your completed ballot to the Elections Committee by the closing date for the election. The election closing date will be posted in the scrolling banner on the website home page.

Your ballot can be folded (in half or thirds) and stapled closed. If you desire for your voting selections to be confidential, place the completed ballot in an outer envelope. Write your name and return address, or your name and membership number on the outer envelope. An alternative to using an outer envelope is to write your name and address, or name and

membership number in the return address field on the folded ballot. For postal delivery of your ballot, write the address for the WAC Elections Committee in the delivery address field, and mail it via postal mail.
